The Florida No Sales Solicitation Calls law, s.501.059, Florida Statutes, directs the Florida Department of Agriculture and Consumer Services to compile and maintain a Do Not Call list for **residential, mobile, or telephonic paging device** telephone subscribers. Business numbers may not be included on the list.

The law prohibits those attempting to sell consumer goods and services by telephone from calling telephone numbers which appear on the "Florida Do Not Call List." However, there are some exemptions: Solicitors may still call 1) in response to an express request of the person being called; 2) in connection with an existing debt or contract; 3) any person with whom the solicitor has an existing or previous business relationship; 4) if it is a newspaper in connection with newspaper business; and 5) if requesting a contribution or donation.

The initial fee is \$10 per number for the first year and the renewal fee is \$5 per number per year. The list is updated quarterly so your check must be received by the date indicated below in order to be placed on the corresponding list.
