1. Ir a la página web www.FreshFromFlorida.com.
2. Haga clic en **Pagar en línea** en la parte superior de la página.
3. Haga clic en la letra **F**.

5. Inicie sesión con su nombre de usuario y contraseña (si no tiene uno, debe crear uno).
